SUBJECT: Updated Listing of Focused Response Departments

Effective Friday – April 1st, 2011, **Spaulding Township Fire Department** shall be **added** to the list of Medical First Response agencies participating in the auto-launch based focused response program.

With the addition of Spaulding Township to the focused response system, the following list is a breakdown of first responder agencies and they're response status:

FIRST RESPONSE AGENCIES USING FOCUSED RESPONSE (AUTO-LAUNCH):

- **Bridgeport** Township Fire Department
- **Buena Vista** Township Fire Department
- **Kochville** Township Fire Department
- **Richland** Township Fire Department
- **Spaulding** Township Fire Department
- **Thomas** Township Fire Department

Departments participating in the focused response will be sent to the scene based on the initial call-type received by Saginaw Central Dispatch. Only when any one of the following complaints are received; Central Dispatch shall immediately activate the Medical First Response agency:

- Breathing Problems
- Carbon Monoxide/Inhalation/HazMat
- Cardiac Arrest
- Chest Pain
- Choking
- Drowning
- Electrocution
- Heart Problems
- Inaccessible Incidents/Entrapments
- Stabbing/Shooting
- Traffic Incidents
- Unconscious
- Unknowns

FIRST RESPONSE AGENCIES RESPONDING TO ALL 911 MEDICAL REQUESTS:

- **Blumfield** Township Fire Department
- **Frankenmuth** Police Department
- **Hemlock Semi-Conductor**
- **James** Township Fire Department
- **Jonesfield/Lakefield** Fire Department
- **Marion** Township Fire Department
- **Saginaw Township** Police Department
- **Taymouth** Township Fire Department
- **Tittabawassee** Township Fire Department
- **Zilwaukee** Township Fire Department

Departments currently remaining with the traditional response model (all calls) should be dispatched immediately when the request is made through 911.
